6. The successful candidates will be engaged initially for one year subject to further renewal of the Contract. However the Commission reserves the right to terminate the contract at any point of time without any notice.

7. It is made clear that the position of JTE requires full time engagement and it will not confer any right on the selected candidates to claim regular appointment in the Commission.
