HON'BLE PM HOSTS NCW'S DELEGATION OF WOMEN STUDENTS FROM NAGALAND



Hon'ble Prime Minister Shri Narendra Modi hosted a delegation of women students from Nagaland on 9th June, 2022, led by Chairperson, NCW, Ms Rekha Sharma. The delegation met the Hon'ble Prime Minister at his residence in Lok Kalyan Marg. The students, sponsored by the National Commission for Women, were on a visit to Delhi as part of the 'Ek Bharat Shreshtha Bharat' initiative. The students expressed their happiness on meeting the Hon'ble Prime Minister. In a freewheeling interaction, they discussed and sought views of the Hon'ble Prime Minister on a host of topics like, his vision for North-East, his experiences in Nagaland, importance of Yoga etc. During the interaction, Prime Minister enquired the students about their experience of visiting and exploring various tourist places in Delhi. He also advised them to visit PM Sangrahalaya and the National War Memorial during their stay in Delhi.

The students also met Hon'ble Union Minister Shri Kiren Rijiju. The students also visited important Government Departments to know more about their functions.

Workshop on Gender Responsive Governance for **Elected Women Representatives**

The National Commission for Women organized Workshop Gender Governance Responsive for elected women representatives (MLAs) under 'She Is A Changemaker' project.

The three-day workshop was organised 22-24 Dharamshala, June in Himachal Pradesh in collaboration with Lal Bahadur Shastri National Academy of Administration (LBSNAA) and the National Gender and Child Centre of LBSNAA. The workshop was attended by 29 participants from the states of Uttar Pradesh, Himachal Pradesh and Uttarakhand. Under the project, NCW has organised 49 training batches in eight states under which around 1700 women representatives of Panchavati Institutions/Urban Local Bodies been given training so far.





Consultation on Transnational Access to Justice to Women Deserted in NRI Marriages

The National Commission for Women organized a Consultation on 'Transnational Access to Justice to Women Deserted in NRI Marriages: Policy & Procedural Gaps' to bring together all the concerned stakeholders designated to provide relief to Indian women deserted by their NRI husbands on one platform and to deliberate upon the challenges and technical issues faced in dealing with NRI matrimonial cases. The Consultation was divided into three Technical Sessions; 'Identification of Problems Faced by Indian Women Married to NRIs/PIOs', 'Access to Justice: Challenges Faced in Indian Legal System' and 'Access to Justice in Countries Abroad: Challenges Faced in Foreign Legal System'.











Seminar on Anti-Human Trafficking Awareness













The National Commission for Women in collaboration with Bureau of Police Research and Development (BPR&D) organized a one-day Seminar on Anti Human Trafficking Awareness. The one-day awareness session discussed introduction, concept, patterns and existing response systems of human trafficking and the psycho-sociological impact of trafficking as well as the role of Civil Society Organizations in its prevention. The Seminar was divided into four Technical Sessions; 'Introduction: Concept, Patterns and Existing Response Systems of Human Trafficking', 'Different Dimensions of Human Trafficking', 'Psycho Sociological Impact of Trafficking' and 'Role of NGOs in Rescue, Post Rescue Care and Rehabilitation'.

The Technical Sessions were followed by a detailed Open House discussion and the Resource Persons suggested the way forward for combating human trafficking. Some of the important suggestions made by the experts were that - every State Commission for Women must have an Anti-Human Trafficking Cell of its own, a Template/SOP for all the organizations to follow in cases of human trafficking, joint training of all the stakeholders, setting up Anti-Human Trafficking Clubs in colleges and educational institutes. Provisions available in legal system including schemes and compensation should be known to everyone in the panchayat level, among other suggestions.

NCW established an Anti-Human Trafficking Cell (AHTC) on 2nd April, 2022 to improve effectiveness in tackling cases of human trafficking, raising awareness among women and girls, capacity building and training of Anti Trafficking Units and to strengthen & sensitize law enforcement machineries.








Nagaland Delegation Meets Union Minister Shri Kiren Rijiju


Inauguration of Programme on 'Empowering Women through Entrepreneurship' with IIM Jammu
