On mission to enhance legal awareness among women, NCW has been diligently organizing Legal Awareness Camps in partnership with the National Legal Services Authority since 2020. Notably, the Valedictory ceremony on August 6th saw the presence of esteemed individuals, including Hon'ble Justice Mr. Sanjay Kishan Kaul, Executive Chairman, NALSA & Judge of Supreme Court and NCW's Chairperson, Ms. Rekha Sharma, lending significant importance to the occasion. NCW's primary goal is to equip women with essential legal knowledge, advocate for gender equality, and ensure justice for all. NCW organized a significant seminar on cyber safety and digital empowerment, convening experts and stakeholders to discuss vital aspects of online security and technology empowerment. During the event, the Hon'ble Chairperson, Ms. Rekha Sharma, emphasized the vulnerability of women in the cyber landscape and encouraged them to confidently embrace digital platforms. Mr. Indevar Pandey, Secretary, Ministry of Women and Child Development, shared inspiring anecdotes about aanganwadi workers who have leveraged technology to bring about positive change in their field, underscoring the transformative potential of digital platforms in empowering individuals and communities. The NCW organised a Regional Consultation Meeting concerning Swadhar Grehs in Thrivanthapuram, bringing together State Women Commissions from Kerala, Tamil Nadu, Andhra Pradesh, Telangana, Karnataka, Lakshadweep and Puducherry. The event witnessed the participation of over 250 attendees and featured discussions on innovative empowerment strategies, shifts in funding, and opportunities for collaboration.



While delivering a speech at a workshop on Preventing Sexual Harassment (POSH) for corporate employees held at Jai Hind College in Mumbai, the Honorable Chairperson, Ms. Rekha Sharma, underscored the significance of ensuring equal opportunities and a secure working environment for women in order to facilitate their contributions to India's advancement.
