NCW collaborated with Rambhau Mhalgi Prabodhini to conduct a seminar on Women Farmer and Daily Wage Labourers on 14th Feb, 2024, in Thane, Maharashtra. The event was inaugurated by Shri A. Asholi Chalai, Joint Secretary of NCW, and Dr. Jayant Kulkarni, Executive Director of Rambhau Mhalgi Prabodhini. Over 300 participants from 27 districts of Maharashtra attended the seminar.



NCW organized a seminar titled 'Awareness on Anti Human Trafficking' in Bengaluru on 28th February, 2024, drawing over 250 participants, including CISF personnel, immigration officials, and representatives from airlines such as Indigo and Vistara. The event facilitated crucial dialogue and action against trafficking, with notable attendees like Smt Anjana Sinha, IPS, Chairperson of Andhra Pradesh Road Safety Authority, Shri S.K Mohanka, DIG of CASO, ASG Bengaluru, and Smt Meenakshi Negi, Member Secretary of NCW, alongside other dignitaries.

In pursuant to vision of “Ek Bharat Shresth Bharath”, six students were selected from states of Assam, Arunachal Pradesh and Meghalaya for inter state student exchange program , a 5 day visit to New Delhi on 27th February, 2024, had the opportunity to visit National Commission for Protection of Child Rights and met Ms Katyayani. The students learnt about the functioning of NCPCR, and how they can volunteer to help one in need.



Continuing the vision of 'Ek Bharat Shreshtha Bharat', NCW led a Women Student Delegation from the Southern Region (Lakshadweep, Tamil Nadu, Karnataka, Telangana, Andhra Pradesh) to Varanasi. On the first day, they visited IIT BHU's Department of Electronics, met with Head of Department Shri Manoj Kumar Meshram, explored workshops, and toured the Central Library. Additionally, they delved into the complexities of Human Anatomy at the Institute of Medical Sciences, BHU. They also visited Temples such as Sankat Mochan, Manas Mandir, and Durga Temple which showcased Varanasi's rich spiritual and cultural diversity.
