At the Outset, the Member Secretary, National Commission for Women welcomed the Chairperson and all Members present in the meeting of the Commission in the new office building of Jasola. Thereafter, with the permission of the chair, the Member Secretary presented, ad seriatim, the agenda items of the meeting.

The following agenda items were taken up for discussion:-

Agenda Item No. 1:- Confirmation of the minutes of the Commission meeting held on 06.11.2015.

Minutes of the Commission meeting held on 06.11.2015 were confirmed by the Commission with a minor correction in the decision pertaining to agenda item no.8 in which it was suggested to correct the sentence (subject to necessary verification) instead of mentioning (verification of status of the University).

Agenda Item No. 2:-Action Taken Reports of PPMRCC and Administration
The Commission noted the contents of the Action Taken Reports.

Agenda Item No. 3:- Evaluation of Special Police Unit for Women and Children (SPUWAC) Counselling Units, Delhi Police through ERU Consultants Pvt Ltd – reg.



The Commission ratified the proposal for conducting Evaluation of Special Police Unit for Women and Children, (SPUWAC) Counselling Units, Delhi Police, Nanakpura through ERU Consultants Pvt. Ltd with a total budget of Rs.13,19,900/- (Rupees thirteen lakh nineteen thousand nine hundred). Relaxation was also accorded to the agency from submitting bank guarantee for the sanctioned amount.

The preliminary report of the said project is expected to be received in March, 2016. The Commission decided to place the same in the public domain, copies of the final report to as many as govt. Departments/institutions like the PMO, MWCD, MHA, etc.

Agenda Item No. 4:- Replicating "Violence Free Home - A Woman's Right", (Special Cell) Project in different States to be supported by NCW - reg.

Regarding replicating Violence Free Home - A Woman's Right (Special Cell) Project, the Commission ratified the following:-

- i. The MoU signed between NCW and TISS-Mumbai, under this project.
- ii. Approval of the proposal and budget initially for 1st year i.e. Rs.1,82,33,627/- (Rupees one crore eighty two lakh thirty three thousand six hundred twenty seven only) i.e. Rs.1,45,95,363/-towards operational cost of 22 pilot special cells in seven states and Rs.36,38,264/- for Technical Support for establishment of 22 pilot special cells with release of 1st instalment of Rs.91,16,814/- (Rupees ninety one lakh sixteen thousand eight hundred and fourteen only) i.e. 50% of the total sanction for starting the work.

Agenda Item No. 5:- Specialised Interns to be placed in the Commission in partnership with leading Universities – reg.

The Commission approved TOR / Criteria for proposal of Paid Internship Programme in National Commission for Women in partnership with leading Universities alongwith the following:-

- It was decided to follow the Planning Commission Model for engaging Interns.
- The Commission approved remuneration / stipend of Rs. 6,000/p.m. for the Interns belonging to Delhi / NCR and Rs. 10,000/- as stipend for outside Delhi students.
- iii. The Interns will bring their own laptop.
- One person / staff of the Commission will be deputed to supervise their work.
- v. The interns will be required to dedicate minimum of 30 hrs per week.
- vi. It was proposed to attach one Intern to each Member of the Commission, depending on the availability.

The Commission ratified the proposal for conducting National Research on Human Trafficking to TISS, Mumbai, with a total budget of Rs.34,73,400/- (Rupees thirty four lakh seventy three thousand four hundred) for a period of 1 year in the three states of Bihar, Jharkhand and West Bengal.

(ii) The budget for technical support for the expansion of the project to all 11 districts of Delhi to Tata Institute of Social Sciences (TISS), Mumbai i.e. Rs.43,44,097/- (Rupees forty three lakh forty four thousand ninety seven only) (round off) for two years i.e. Rs.21,61,472/- for 1st year and Rs.21,82,625/- for 2nd year, including two co-ordinators with salary @Rs.35,000/- per month.

The Commission approved the following measures in above agenda:-

 Lay down strict timelines- The approval letter / 1st sanction for release of funds to the organization may clearly specify that the

fri

programme should be organized within three (3) months of receipt of funds, which may vary in the cases of research studies (or the date approved on file for conducting the programme) and all required documents must be submitted to the Commission within two months after undertaking the programme.

- ii. The provision for recovery of interest on defaulting- Further delay in submission of documents, beyond two months of organizing of programme, a clause for recovery of interst@10% from the due / remaining instalment or from the bank guarantee, may also be inserted in the terms of sanction order.
- iii. An interest @ 10% per annum may be recovered in case the organization does not undertake the sanctioned programme within three months of receipt of funds from the Commission.

In the ongoing / pending cases where the above mentioned clause have not been stipulated in the sanction, a circular may be issued / uploaded in the website for early compliance and settlement of pending cases.
