(iii) NCW-IIMB's collaborative online training programme for aspiring women entrepreneurs, namely, 'Empowering Women through Entrepreneurship'.

The Commission deliberated and noted the training programme for aspiring women entrepreneurs, namely, 'Empowering Women through Entrepreneurship'. Salient features of the training programme are as under:

- NCW has joined hands with Indian Institute of Management Bangalore, for a collaborative six weeks online training programme to support and sponsor digital learning of 5000 (Five thousand) aspiring women entrepreneurs.
- NCW will pay a cost @ Rs.3000/- (Rupees three thousand only) per participant to IIM, Banglore.
- > The programme has been officially launched on 4th March, 2021 and applications are invited on the MyGov Portal. The formal launch

ceremony was conducted in Leh, Ladakh on 4th March, 2021. The budget estimate for the launch ceremony was Rs. 4,32,920/-.

Agreement has been formally signed with IIMB detailing all necessary modalities relating to the program. A copy of the agreement is attached herewith. As per the payment terms of the agreement, a sanction of Rs.45,00,000/ (Rupees forty five lakhs only) has been made in favour of IIMB on signing of the agreement.

A brief on the training programme and copy of the Agreement between Indian Institute of Management, Bangalore through NSRCEL and National Commission for Women will be forwarded to all concerned after approval of the Minutes.
