#### MINUTES OF THE 28TH MEETING OF THE NATIONAL COMMISSSION FOR WOMEN, HELD ON THE 17TH OCTOBER, 1996

The twenty-eighth meeting of the National Commission for Women was held on the 17th October, 1996 under the Chairmanship of Smt. Mohini Giri, Chairperson, National Commission for Women. The following were present:

Sh. S.C. Ghoshal, Pay & Accounts Officer, all Consultants, Section Officer and Assistant-in-charge were in attendance to render assistance as and when required of them.

In her opening remarks the Chairperson conveyed a apology offered by Smt. Padma Seth, Member's inability to attend the meeting as she had been summoned by the Court. Smt. Kailashpati, Member, could not attend the meeting as she had taken leave to celebrate Dussera in her Home Town.

Action taken statement on the minutes of the 27th meeting of the Commission :

Representation of Class IV Staff for regularisation of their services :

It was noted that the Draft Recruitment Rules in respect Groups C & D posts is being examined in the Legislative Department of the Ministry of Law for its final approval.

The following suggestions were made with regards to the Class IV staff and Staff Car Drivers:-

- (a) A chart showing the deployment of the staff of the Commission including staff car drivers should be circulated for the information of all in the Commission.
- b) Shri Arora, Assistant, should be made incharge of all the Staff Car Drivers, Their maintenance including deployment of Drivers, under overall Supervision of Member Secretary.
- c) Class IV staff should be instructed to cleam the office rooms of the Commission every day without fail.
- t) The Peon attached to any Member, who is absent from the Commission for more than 2 dyas, should be deployed elsewhere.

# (ii) Appointment of Shr. S. Ramaiah as Legal Advisor:

It was noted that the Office Order for the appointment of Shri Ramaiah as Legal Advisor had been issued.

### (iii) Appointment of a Consultant (Legal) :

It was noted that Ms. Meenakashi Sinha had been appointed as a full-time Legal Consultant and posted in the Complaint Cell.

#### (iv) Review of project proposals :

A list of project proposals, which was prepared by Consultant (RNB) and Consultant (RN), was circulated in the meeting. This was taken up for review in the meeting as indicated in these minutes in the subsequent paragraph.

### (v) Payment of allowance to Prof. P.M. Bakshi:

It was decided that all dues to Prof. P.M. Bakehi should be paid without any further delay, if necessary by starting a new file. Member (PS) (vi) Release of grant of Rs. 50,000/- to KARUNA
for organising workshop on Panchayats
Training Programme:

It was mentioned that a grant of Rs. 50,000/- was released to KARUNA for organising the Workshop. It was suggested that Member (KV) should get the project proposals from Ms. Margaret Alva and further process it. The grant of Rs. 50,000/- was a part payment made to meet immediate expenditure on miscellaneous items relating to organising the workshop,

### ii) Follow up action to be taken up on the Charter of Demands/Reports:

It was mentioned that no action has so far been taken in the PM's Office on the Charter of Demands submitted by the Commission. It was suggested that the Consultant (C.R. Sinha) might put up (draft) letter to the PM, HRD Minister and the Secretary, D/W & CD seeking their replies to the Demands.

It was further decided that the recommendations contained in the various study/seminar/workshop reports sponsored by the Commission should be sent to the various concerned Ministries/Departments for necessary action/implementation as the case may be.

#### (ix) Anti-arrack project proposal :

In so far as Uttarakhand region is concerned action has been initiated by Member Secretary. With regard to the other regions of the country, the Members concerned with respective States will process the project proposals.

#### (x) Recruitment of Consultants :

It was mentioned that a detailed letter was sent to the Secretary, D/W & CD and a reply is awaited from the Secretary in the matter. A meeting will be convened shortly with the Deptt. of W & CD in connection with recruitment of Consultants from amongst the retired Government employees. It was suggested that Members might raise the points concerning their Consultants during the course of the discussions.

#### (xi) Setting up of Computer Cell:

It was noted that the work relating to the conversion of the present Reception Room into Computer Cell had already begun. With regard to the purchase of Computers, it was stated that the Quotations had been received, with ZENITH Computers firm quoting the lowest rate. An Expert Committee with Dr. Singh of the NIC in Chair was set up for the selection of the Computers. At this stage it was mentioned in the meeting that although the quoted price of the Zenith company was the lowest, the quality of the

### 9th Pive Year Plan :

It was mentioned in the meeting that two successive meetings of the Expert Committee on the 9th Five Year Plan were held on the 30th Sept., and 18th Octo., 96 in the Commission to formulate the Plan proposals of the Commission. After some discussion it was decided Dr. (Ms.) Maya Daruwala would be appointed as ADvisor for the preparation of the 9th Plan in respect of the NCN. Dr. Daruwala would function as a facilitator and would elicit information from the Commission to draft the Plan by the 10th November, 96. Ms. Daruwala will function on an honorary basis but will be paid a token lump sum of Rs. 12,000/- to meet her expenses on various miscellaneous items. She will also continue guiding the Commission on the implementationof the 9th Plan projects in so far as these pertain to Women.

It was also decided that Dr. (Ms.) Kusum Mittal would be appointed as a Consultant on an honorary basis for the preparation of "FUTURISTIC PROJECTS" proposals within a period of three months from the date of her taking charge of her

Proposal from FORCES, New Delhi, for holding one day symposium on the Child Care needs of Women workers:

Consultant (PS) explained in brief the proposal and the action so far been taken in the matter. She indicated that some functionaries from the Planning Commission would be participating in the Seminar. The proposal for the release of a grant of Rs. 55,000/- to the FORCES for organising the Seminar was approved in the meeting.

- C. Chairperson's visit to Jubbalpore for attending Mahila Adalat organised by the All India Women's Conference on the 29th September, 1996

concerned were also present on the day of the Adalat. As many as 980 cases were taken up for the Adalat in 18 Courts. Chairperson felt that the Adalats could be organised without the assistance of the Advocates. It was an open Court proceedings. The Adalat would have been fully successful but for the fact that a big crowd of miscreants instigated by certain Advocates wanted to stop the proceedings in the Courts. The crowd resorted to brick-batting when the Counselling was going on. It was the case of male chauvinism raising its ugly head.

At this stage the Judges went back to their rooms. It all started when the Chairperson questioned an Advocate as to how he could stop a woman from going to her husband. Chairperson felt that the underlying phenomena of this disturbance was that men were getting frightened about the gradual empowerment of women in all the sectors of the society. However, one redeeming outcome of this incident was that almost, the women present in the Adalat formed a human chain to prevent the disturbance going out of control. Letters have been sent to the Home Minister and the Home Secretary about this ugly incident.

D. Chairperson's visit to Jaipur, Rajasthan on the 15th October, 1996 for attending Sathins' meeting

Chairperson narrated in brief about the meeting of the Sathins held at Jaipur, Rajasthan, on the 16th October, 1996. It was

noticed that the Sathins were rendering dedicated service towards the uplift of rural women and that they were implementing as many as 32 schemes. Despite all their dedicated service, they are being given only Rs.250/- per month. The Government of Rajasthan is not accepting any increase in the salary of the Sathin. The Cabinet Sub-Committee of Rajasthan is however considering the proposal and will convey the decision by the 30th October, 1996. Incidentally the agitation launched by the various women activists with the help of the NGOs against the judgement of the District Court, Jaipur, in Deorala Sati case, Chairperson stated, received wide publicity.

The meeting ended with the vote of thanks to the Chairperson.
