Bal Vivah Virodh Abhiyan organised by Non-Government Organisations in the States of Andhra Pradesh, Madhya Pradesh, Rajasthan and Uttar Pradesh

Members briefly discussed the Bal Vivah Virodh Abhiyan (BVVA) in respect of states they visited and impact of the BVVA in the concerned states.

Member (N. Hussain) who visited Rajasthan stated that the Abhiyan was launched in 7 districts with the help of 7 NGOs. The abhiyan had a very positive impact in the states as 72 marriages of the children were stopped. The NGOs had

and the State Governments.

Member (K.S.Reddy) stated that the impact of the BVVA in the state Andhra Pradesh was very positive. She informed that 7 organisations were involving the Abhiyan and it had a very positive effect. However, she pointed out that in South, no importance is attached to AAKHATEEJ in the matter of child marriag CP pointed out that this may be kept in view when further programmes are finalise.

Member (A.Uike) stated that out of the 4 organisations, reports from organisations are awaited. These will be called for. She informed that response to Abhiyan was very encouraging. In Panna district more than 1000 ladies participal and the State Government was very supportive.

CP observed that statistical data should be included in the report.

Member (B.R.M) informed that the programme was conducted from 1.5.2 to 15.5.2002 in Lucknow(U.P). The programme was appreciated. representatives of UNICEF, State Governments appreciated the programme. It launched mainly at 5 places, including Azamgarh etc.

M.S pointed out that the BVVA campaign should not be launched year a year as it is the work of the functionaries of the State Governments. The law on subject and our proposals for amendment are on record. The NCW should look the reasons for child marriages such as girl child literacy, schemes of the state central government for education, prosecution in states, mid-day meal for child 93rd Constitutional amendment bill – education from 0 to 6 age group children, he for tribal and scheduled caste girl children, reservation in jobs and schools, rol gram panchayats/women surpanches/corporators. She was of the opinion Commission should launch special Abhiyan on the issues of female foetis infanticide, child rape, dowry and sale of children/trafficking.

CP observed that recommendations of BVVA, recommendations of the public hearings on the subject and recommendations of the Expert Committee Marriage Restraint Act may be assimilated and final recommendations out of the recommendations, may be sent to the Government while sending recommendations to the Government. It may be ensured that there should be contradiction of the recommendations already sent to the Govt. on the subject.

Member(K.S.Reddy) was of the opinion that there should be no duplicated of the work. Member(A.Uike), Member(B.R.Maurya) and Member(N. Hussain) of the opinion that once we have initiated the programme, we should not leave abhiyan and next year also we should launch similar abhiyan.

CP observed that they should give their suggestions how we can launcl abhiyan next year in more effective manner. (Action -- Sh. TNS)

Chairperson held a meeting with Members (K.S. Reddy, A. U. Hussain, B.R. Maurya) on 22nd May, 2002. Present in the meeting w Joint Secretary and Deputy Secretary. The following issues were discuss decisions taken:-

Setting up of the Committee to examine the working of the Co Cell.

Members were informed that the Chairperson proposes to set up Committee to streamline the working of the Complaint Cell adapting profollowed in the other National Commissions, i.e. National Human Commission, National Commission for Minorities and SC/ST Committee needs of NCW. The Committee would comprise Joint Secretary Smt. Saraswati Haider (PRAJA), Shri Subrat Birla (NCW's Atto Retainer), Shri Anees Ahmed (Advocate) and Shri S.M. Imran Ali (Law NCW).

II. Follow up on the Gujarat Report.

It was also felt that the Commission should be actively involved in monitoring delivery of the package of relief and rehabilitation announced by the Prime Minister.

III. Interaction with the Parliamentary Committee on Empowerment of Women on "Violence Against Women".

The Commission was informed that the Parliamentary Committee on Empowerment of Women had scheduled a meeting on the subject "Violence Against Women" on 14th June, 2002. Members were requested to furnish notes which could be included in the material which should be sent to the Committee.

IV. Sexual Harassment at Workplace.

Chairperson informed the Commission that the present Bill of NCW had several lacunae. The Bill had been discussed in two meetings of the Commission, some feedback had been received from NGOs. The following proposed course of action was agreed upon:

(a) A small Drafting Committee would be set up to prepare a revised Bill incorporating all the inputs received so far. The names suggested were Shri Moolchand Sharma (Academic),

Shri Anees Ahmed (Lawyer), Smt. Amarjeet Kaur (Activist and Trade Unionist) and one representative of the Ministry of Labour. Members were requested to suggest names of persons, preferably Delhi based, for the Drafting Committee.

- (b) The Draft Bill would be placed on the NCW's Website.
- (c) A wide consultation meeting would be organised in collaboration with the Ministry of Labour.
- (d) Letters would be sent to all national level women's organizations seeking their views on the draft Bill after it is revised.
- (e) Letters would be sent to all Ministries and Departments of the Central and State Govt. for setting up of Complaints Committee.
- (f) On the lines of the meetings held within the Commission on the implementation of the Vishaka Judgement, meetings may also be held at

the State levels in collaboration with State Commissions for Women, if possible, and NGOs where there are no State Commissions for Women or where cooperation of SCW is not forthcoming. On this point a decision would be taken only after Member Secretary returns from leave as series of meetings within the Commission had been convened by her.

V. Setting up of Expert Committees.

Chairperson spoke about the necessity for NCW to set up Expert Committees to examine issues in terms of Sec. 16 of the NCW Act.

These Committees would be in addition to those already set up.

One Member would be in charge of every Expert Committee. An officer of the Administration and some coordinators would assist in the working of the Committee. It was also proposed to select one anchor person from out of the experts of a Committee to convene the meetings, prepare background papers etc. Such anchor person may be paid a small honourarium ranging from Rs.3,000/- to Rs.6,000/- per meeting. The proposal would be finalised after the matter is examined from the perspective of administrative and financial rules.
