**Commemoration of 25 years of establishment of National Commission for Women-
financial assistance to State Commissions for Women**

The Commission approved the proposal brought out in the Agenda Note. The Commission also directed that the State Commissions for Women may be advised that the amount may be utilised for spreading awareness about the rights of women and also other women related issues and that the duly certified utilisation certificate may be submitted by them to the National Commission for Women within a month of event being organized. The Commission also decided that the proposals received from the State Commissions for Women may be cleared at the level of Under Secretary and Pay & Accounts Officer.

Agenda Item No. 3:

**Commemoration of 25 years of establishment of National Commission for Women-
Hospitality arrangements for Artists at India Habitat Centre**

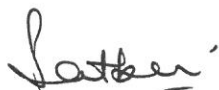
