The Commission deliberated and accorded approval for undertaking media campaign of National Commission for Women through National Film Development Corporation (NFDC) by inviting DAVP empanelled Private TV Channels, FM Channels, Digital Cinema Theatres and Websites at DAVP rates, as per details given in the Agenda. The Unit had reported increased productivity by 88% over a period of Five years. The Commission approved sharing of the initiatives of Hindustan Unilever with other corporate as a Success Story for emulation.

Agenda Item No. 201/T/4

Annual Action Plan of National Commission for Women for the year 2020-2021.

The Commission was informed that the Annual Action Plan had been shared with the Ministry of WCD as well as the Department Related Parliamentary Standing Committee. The Commission approved the Annual Action Plan of NCW for forthcoming Financial Year, with following changes:



- (i) Law reviews to be undertaken during FY 2020-2021 may be limited to three on viz., Mental Health Act, 2017; Protection of Women from Domestic Violence Act, 2005 and Cyber Security Law and Regulations;
- (ii) Digital Shakti programme shall be taken up in 07 states during the FY 2020-2021.

The Commission also observed that the number of Seminars could be increased depending on proposals received from State Women Commission. Also, considering the low number of proposals received from North East Region, the Commission approved that proposals from Government organizations like SWCs and Universities/Colleges, shall be considered throughout the year, subject to procedural diligence.
