# Agenda Item No.5 Problem of Female Foeticide

It was decided that the Commission will launch a campaign against Female Foeticide by holding awareness camps. For holding camps, 5 or 6 state will be identified based on adverse sex ratio. In the campaign, the representatives of Indian Medical Association, Sonologists and NGOs working is medical field should also be involved. An Expert Committee on Gender & Health shall be constituted. These campaigns will be held in identified states. Campaign against the Female Foeticide will be launched at three levels – at college level at district level and finally at state level.

For College level, campaign will be held through a lead college who will coordinate with ten colleges, including the lead college. For this, a sum of Rs.25,000/- per state will be paid by the Commission in total for all the ter colleges. Each Lead college would be required to give a report of the proceedings of the camps.

For District level programes, four Gramin Camps will be held in one district in a state, for which Rs.20,000/- will be sanctioned per state by the Commission @ Rs.5,000/- per camp to the State Commission for Women. The concerned SWC would be required to give a report on the campaign carried out in the state.
