#### 26 (1) Women in Industry

The proposal of M(S.Malaiya) on Women in Industry was discussed. CP observed that the proposal involving an expenditure of 46 lakhs i.e. 27 lacks for 9 National workshops and 19 lakhs for a study was unheard of for the Commission and not pliable. CP further stated that such consultations have been conducted at an amount ranging from Rs. 6,000/- to Rs.10,000/- in case of rape laws, dowry laws etc. At that stage, M(S.Malaiya) stated that she was not aware that such big amounts are not sanctioned by the Commission. An addendum given by M(S. Malaiya) is annexed.

It was decided that the proposal will be examined by Accounts and Research & Studies Cell.
