Minutes of the 170<sup>th</sup> meeting of the Commission held on 28<sup>rd</sup> November, 2016 at 1200 hrs in the Conference Hall of the National Commission for Women, New Delhi.

At the Outset, the Member Secretary, National Commission for Women welcomed the Chairperson and all Members present in the meeting of the Commission. Thereafter, with the permission of the chair, the Member Secretary presented, ad seriatim, the agenda items of the meeting.

The following agenda items were taken up for discussion:-

Agenda Item No. 1:- Minutes of the Commission meeting held on 23<sup>rd</sup> August, 2016.

Minutes of the 169th Commission meeting held on 23.8.2016 were confirmed by the Commission. The amendments proposed by the PPMRC cell were noted by the Commission.
